### **Our History: Celebrating 25 Years**

### 1998

PCCI is founded by Atlanta business leader and affordable housing advocates Bruce Gunter and Lori Mills.

### 1999

Atlanta's first centralized facility for homeless services, the Resource Opportunity Center, opens.

Respected Atlanta architect Larry Lord becomes the first chair of PCCI's board.

### 2005

Mayor Shirley Franklin opens the Gateway Center to address the city's need for shelter and transitional housing beds for those experiencing homelessness.

### 2009

The American Recovery and Reinvestment Act of 2009 is signed, which includes \$1.5 billion for a Homelessness Prevention Fund.

### 2012

The U. S. Department of Veteran Service "Supportive Services for Veteran Families" program begins to address the number of veterans experiencing homelessness and housing insecurity. PCCI is one of 85 grantees to be awarded funds in 2012 and every year since.

### 2013

The Kids Home Collaborative is formed through PCCI's work with DeKalb County Schools, which is acknowledged as a promising start by the National Alliance to End Homelessness and the U.S. Department of Health and Human Services.

### 2017

Long-time PCCI leaders Jimiyu Evans & Margaret Schuelke are named CO-CEOs.

Atlanta is selected as one of five cities to utilize federal Temporary Assistance to Needy Families funds; PCCI plays an important part in this initiative.

### 2021

PCCI plays a key role in the City of Atlanta's pandemic response, deploying federal funding to help people experiencing homelessness secure housing to reduce the spread of COVID-19.

### 2020

PCCI is awarded \$2.5 million from Bezos Day One Family Fund.

### 2023

Thrive Sweet Auburn opens.

### 2024

PCCI celebrates 25 years of improving opportunities for people experiencing homelessness.



PCCI moved 5,600 people into housing over the last decade, with 80% exiting to positive outcomes

# A New Home at Thrive Sweet Auburn

In April 2023, eight years of planning and hard work culminated in the opening of Thrive Sweet Auburn. Built on the former site of our headquarters on Decatur Street near Downtown Atlanta, every aspect of this mixed-use development was intentionally designed to meet the diverse needs of our clients, our partners, our neighbors and our team.

The site features community amenities including a shared kitchen, outdoor gathering space and parking.

Thrive includes 12,000 square feet of commercial space. Tenants include PCCI, First Step Staffing and others who support residents and build community.

According to the Atlanta Point in Time Count, **9.4% of people experiencing homelessness in Atlanta are veterans of the United States armed forces**. PCCI is honored to help these individuals secure housing and access services.

PCCI has a dedicated team of professionals who understand the unique needs of service members and how to navigate the programs and systems available to help veterans achieve their goals.

### In 2023, PCCI supported 300+ veterans.

Removing Limits, Increasing Resiliency

Over the last year, PCCI implemented a direct funds transfer pilot program that provides qualified recipients with funds to use at their discretion to pay for priority needs. This kind of support offers predictable income, fostering stability and financial literacy.

Built from a pilot funded by the Annie E. Casey Foundation and scaled thanks to a grant from the **Bezos Day 1** Families Fund, this program is transforming the lives of families.

### By the Numbers

\$380,000 distributed between 2022 and 2023. Our program supports
100 recipients, who represent a total of 250 people living in their households.

Funds are provided for **12 months** to each recipient in the amount of **\$400 per month**



In 2023, **PCCI** and the **Georgia Department of Family and Children Services** came together to identify ways to reduce the number of families involved in the state's child welfare system. A pilot program in Fulton County that offers early intervention housing support is proving to be a successful model. Program partners plan to expand the initiative, aiming to keep Georgia families together and in stable housing.


